RYAN'S HISTORY

1987

In March, Larry Ryan starts the RYAN Lawn Care out of his home in Overland Park, Kansas.

1994

After 7 years in business, RYAN eams \$1 million in sales

2000

RYAN's first business expansion out of the KC Metro area, opening a branch in Wichita, Kansas.

2003

RYAN acquires TNT Tree Service, Inc. and enters the Springfield, Missouri market under the name of RYAN's TNT Lawn & Tree.

2007

RYAN's growth continues, reaching a new milestone with the employment of over 100 full-time associates.

> 2010 In January, RYAN opens up operations in St Louis, Missouri.

2013

RYAN breaks through the \$25 million revenue mark!

2017

RYAN acquires four businesses - acquiring three irrigation companies in Wichita (Lawn Sprinkler Systems, Thompson Irrigation, and 4-Star Irrigation) and a landscaping company in Overland Park (Sparker Landscaping). Employee count grows to 300.

2020

RYAN hires Roy Heinbach as CFO, following the retirement of longtime CFO, Darell Nutt. Roy brings two-plus decades of leadership and financial experience to the team.

In September, RYAN establishes its first Missouri branch, in Lee's Summit, Missouri. In the same year, RYAN exceeded \$5 million in sales.

2004

RYAN continues to expand its operations, with another new branch opening in Tulsa, Oklahoma, in January.

2008

RYAN opens an Irrigation Department, offering sprinkler system installation and full-service, with the purchase of Lawn Magic, Inc.

RYAN celebrates its 25th year in business and another great year of sustained growth with 180 full-time associates.

2014

In April, RYAN purchases an irrigation company in Tulsa; in May RYAN purchased a tree pruning business in KC, and in December a small engine sales and service business in Lenexa.

2018

In November RYAN starts a new initiative called Great Game of Business (GGOB) in a continued effort to "create a business of businesspeople - who think, act and feel like owners"

2021

RYAN promotes Phillip Fisher to Chief Operating Officer. Phillip served as the Wichita Branch manager for nearly a decade prior to his new role.

The major driver of RYAN's early success was the underlying culture of Act Like an Owner. Larry's 'work hard, do the right thing, customer-focused' culture drove RYAN's rapid early growth!
